

- u. To take up all any constructional development activity programmes under various developments that involve poor labor and rural employment programmes.

POWERS OF THE TRUSTEES: -

The Board of trustees shall have the control and management of the trust the trustees named above shall be the first board of trustees who may co-opt or select the other trustees.

For the furtherance of the objects, i.e., for service to the community in general and to the poor and weaker sections of the Trust as mentioned in Clause 4 the trustees will have the following, powers which will be exercised by them:

- To accept any donations, contributions, grant or subscriptions in cash or in kind from any person, body of persons or trust.
- To apply the whole or part of the income of the trust or accumulation thereof in whole or part of the corpus of the trust fund for any one or more of the objects of the trust as the trustees may, in their description from time to time, determine.
- To convert and deal with investments comprised in the trust fund and/or to carry the investment for the time being in the modes prescribed u/s.11 (5) of the I.T Act, 1961. And each other provisions and amendments thereof from to time.




